Meeting called to order at commenced at 7:12 pm

Speaker: Chris Jacobs: Erie County Clerk

- Will not speak to the general body tonight
- Spoke to Board about closing the bars at 2 am

Livestock within City Limits:

- Candy H.:
 - o A house on Merrimac had hens and roosters on the sidewalk
 - Man was given 24 hours to remove birds
 - o It is against the law can have five birds legally, but no roosters
 - It was extended to 48 hours
 - The birds was seen walking in and outside of the house
 - By November 30th, the birds were supposed to be gone
 - o The birds were hidden
 - The owner of the property lives in Las Vegas
 - The management company could not be contacted
 - The birds have since been removed
 - Now that the birds are gone for now, and the UB HOME program is being implemented, what is the next step in fixing this blighted house?
 - o Who is responsible for this house?
 - Doris and the Councilman Wyatt have been very helpful in trying to remove the birds
 - The codes say that the neighbors must agree to having five hens
 - Have not yet heard about neighbor complaints
 - With Linear Park, this is unacceptable
 - o Residents came from Texas

Mickey V.:

- There aren't many neighbors to this location
- o These chickens were walking on the sidewalk
- Will work with the resident and help them understand the rules and regulations
- o Five cars with Texas plates talked with son to learn more about family's situation

Fred B.:

- City charter addresses foul regulations in the City –individual must be licensed to own in city
- Property manager must be registered in the city
- We need to get a hold of the property manager: his phone has been disconnected
- The city needs to share information concerning the direction this property is going: manager, owner, etc.
- The managers and owners need to be held accountable, and this information is part of the inspectors knowledge – should be public
- We need to be demand that we are part of this solution
- o Bottom Line: we can no longer try to compromise
- There is a need for succinct information for this property
- o The landlord in Las Vegas does not care about what is going on this property
- County of Erie provides 80-85 percent of payment to housing costs to those on public assistance

Candy:

He had contacted the guy in Las Vegas but not yet the property manager

Ray:

o There is nothing wrong with working with residents

• Fred:

- We need to know exactly what is going on
- The letter of the housing laws is not being upheld by these landlords
- As a city of Buffalo citizen, you have the right to make an educational decision on what to choose for housing
- The tenant is not the issue: it is the quality of housing elements

Mickey:

- We are making initiatives to work on this together to assist these people
- We are helping the family clean up the house
- We are going to contact the house
- Blight draws these types of action crime, etc. are drawn to these types of places

Updates on Campus North:

- Not going to be a student rental property will be focused on young professionals
- Want to help with the Impact Team
- Aim to help the neighbors and community
- Will be open to working with UHC, landlords and neighborhood organizations to boost the image and quality of life of the community

Development of Legacy Development:

- Mickey:
 - Open house in January
 - Will be starting at \$1000 or higher a month
 - For students
 - Own security in compound with amenities
 - Will be hiring students
 - o 250 units
 - Located on Main and LaSalle
 - Within walking distance of the subway
 - Behind the William Price development
 - Students will have more choices
 - Businesses may come to serve the community base and spread the population of students
 - If they actively engage in the community
- Gail W.:
 - o Will students go to party houses?

Rails to Trails:

- Everything is up
- There is still some cement work to do but will be done next year
- Black top for now until they can finish next year

Gary:

- Lives on Northrup Street and individuals are parking illegally
- Students park where they shouldn't during plow times
- The new walkway and bricks are in the way of a big truck to move on the street for plowing purposes when cars are in the way
- No one can turn around because of the traffic on the street
- The cars never change the sides
- The sign is part of the car port
- Solution? Move the sign to the car port
 - o Fred B.: "Tag and Tow" by the City of Buffalo is essential

- The city needs to take care of these cars
- If the cars weren't parked there then cars could turn around
- In the rental registry law, imported by the City of Buffalo, it lost the part where it makes sure there is enough parking for each resident
- o In Rochester, if you rent to 5 students, then you have to have 5 parking spots
- Those cares need to be moved so that it can be plowed on alternate days
- Enforcement of City code is not there
- Councilman Wyatt: We need to talk to city planning and help students understand the code
 - Mickey: let's work with the neighbors it's unrealistic to have a parking spot for each resident
 - We may be able to move the boulders

Capen Garden Walk:

- Linda Young, Chairman of Capen Garden Walk:
- Poster Art contest is beginning advertisement and application are on FB page and will be on website
 - The University Heights Arts Association will host a poster art competition and related exhibition
 - The UH Arts Association set it all up and will be judging the pictures and will be giving the prize
 - The photos will be due in the coming months and the poster will be made from the winning artwork
 - All submitted artwork will be included in an exhibit in Buffalo and in Lockport at UH Art Association Art Crawl
 - Those who submit will have their artwork exhibited

 - Some money will be allotted one or more people to supply, improve or start a garden within area of garden walk

 - Members are paying \$5 a month more to have them but the lights aren't working
- Is there anything going on with sidewalks with Englewood and Kenmore?
 - Sidewalks will be reconstructed in Spring
 - The meetings have ended but this issue can be brought up again
- Mickey V.:
- If you look at Main Street, our signals from Parkside to Bailey are not synchronized
- There has been money set aside to do this project but this has yet to be done
 - Ray R.:
 - Lights out on corner of University
 - National Grid needs to do this
 - Fred B.:
 - o The section on 311 for lights by email
 - They need to notify National Grid
 - Until they notify National Grid you cannot report it to National Grid
- Councilman Wyatt:
 - When you call 311 the city should be responding right away to the request
 - 311 should be responding within 2 days
 - We will follow up with this issue
- Meeting in January concerning the bar closing time
 - Mickey: the UHC will be told when the meeting is for the potential change in bar closing time
 - Chris Jacobs said he would be sending information. Will become more informed with information. Chris Jacobs said that he would return
